

## April 20<sup>th</sup>, 2023 Supervisors Minutes

Chairman Clapper called the April 20<sup>th</sup>, 2023 Supervisors meeting to order.

The following members were present: Don Clapper, Ted Bittinger, Mike Ferguson

The minutes from the March 16<sup>th</sup> meeting will be reviewed at the next meeting.  
The Treasurers report was distributed to each Supervisor for review.

Chairman Clapper opened with Privilege of the floor – No Comment

Terry O'Hara at 2004 Springview Drive has a septic malfunction and is required to install a new seepage bed. Unfortunately, the only available location for the site encroaches into the 100' well isolation distance. Bill Bruck did a hydrogeology study and determined the encroachment will likely have no impact on the existing well. Jon Piper recommends approving this encroachment request. On a Ferguson/Clapper motion carried unanimously, the Supervisors approved the request.

A representative from the New Franklin Volunteer Fire Co. was in to inform the Township that they signed a contract with Pierce for the purchase of a new engine. The proposed cost is \$1,035,751. Once ordered the unit is probably 2-3 years out for delivery. They are anticipating financial help with the purchase. Chairman Clapper shared with him how we offered to assist Fayetteville.

The Mason Dixon Modified Car Club has requested the use of Norlo Park for a Car show on September 10<sup>th</sup> or 17<sup>th</sup> (9am – 4pm Sunday). They expect 5-10 vendors with 1-2 food trucks. (Chairman Clapper will proceed with the reservation and entertain further discussion with the interested party in reviewing their needs and desires for their event)

Billy Wishard from Fayetteville Fire Department responded to the Supervisors March 16 response to their request for financial support. A copy of that response was distributed to each Supervisor for review.

The LDP clock for Kyner's Auto is about to expire. On a Bittinger/Clapper motion carried unanimously, the Supervisors approved the request for a 90-day extension.

The LDP clock for the Fire Training Center is about to expire. On a Ferguson/Bittinger motion carried unanimously, the Supervisors approved the request for a 90-day extension.

Resolution #2023-06 for an updated traffic signals maintenance agreement with PennDot. On a Bittinger/Ferguson motion carried unanimously, the Supervisors approved the Chairman to execute the agreement.

Resolution # 2023-07 for an individual on-lot septic system for the new Old German Baptist Church proposed on Stump Lane(T-499). This resolution is required for the submission of the planning Module to DEP. On a Ferguson/Clapper motion carried unanimously, the Supervisors approved the resolution.

Shalom has requested the help of Marion Fire Police again this year for their 5K road race during their annual Dutchfest. The race will be from 8:20-9:50 am on Saturday May 6,2023. On a Bittinger/Clapper motion carried unanimously, the Supervisors approved the request.

On a Ferguson/Bittinger motion carried unanimously, the Supervisors approved the paying of the bills.
