

## **January 15<sup>th</sup>, 2026 Supervisors Minutes**

Chairman Clapper called the January 15th, 2026 Supervisors meeting to order.

The following members were present: Don Clapper, Greg Thomas.

The minutes from the December 18th meeting were approved as written.  
The minutes from the January 5th Re-organizational meeting were approved as written.

The Treasurers report was distributed to each Supervisor for review.

Chairman Clapper opened with Privilege of the floor – No Visitors

Chairman Clapper shared a quote for a new Western Star single axle dump truck chassis from River's Truck Center that has been budgeted for 2026, (they are a COSTAR dealer). A copy was distributed to each Supervisor for review. On a Thomas/Clapper motion carried unanimously, the Supervisors approved the Chairman to execute the agreement.

Chairman Clapper shared a quote for a fit out for the new Western Star single axle dump truck from PA Municipal that also has been budgeted for 2026, (they are a COSTAR dealer). A copy was distributed to each Supervisor for review. On a Thomas/Clapper motion carried unanimously, the Supervisors approved the Chairman to execute the agreement.

On a Thomas/Clapper motion carried unanimously, the Supervisors approved Resolution # 2026-02. A copy was distributed to each Supervisor for review. This resolution is a Winter Services Agreement from Penn Dot to treat the roadways for the winter for a 5-year term. The roads are sections of Guilford Springs Rd. and Archer Dr. that have been turned over to the Penn Dot in preparation for the Exit 12 interchange project. On a Thomas/Clapper motion carried unanimously, the Supervisors approved the Resolution, which is to approve the Chairman to execute the agreement.

On a Thomas/Clapper motion carried unanimously, the Supervisors approved a Land Development plan for Franklin Learning center to increase parking at their facility. The plan has been reviewed by Franklin County Planning, Guilford Township Planning and our Zoning officer. This motion was made subject to all fees and comments being addressed.

Chairman Clapper discussed the EMS money that is budgeted for 2026 for a supplemental contribution. On a Thomas/Clapper motion carried unanimously, the Supervisors approved to distribute the monies evenly between the three emergency services providers that reside in our Township.

On a Thomas/Clapper motion carried unanimously, the Supervisors approved the paying of the bills.
