## January 18th, 2024 Supervisors Minutes

Chairman Clapper called the January 18<sup>th</sup>, 2024 Supervisors meeting to order.

The following members were present: Don Clapper, Ted Bittinger, Mike Ferguson.

The minutes from the December 7<sup>th</sup> meeting, and January 2<sup>nd</sup> Organizational meeting minutes were approved as written.

The Treasurers report was distributed to each Supervisor for review.

Chairman Clapper opened with Privilege of the floor –

Mr. Ackerman, gov't relations coordinator from the Penn National Community Association was present and updated the supervisors on the positive impact on speed the flashing lights have had since installed. He presented a few questions to the supervisors: The grant money that was received by the GWA & GTA, can any of it be used to add fire hydrants in areas of PN that do not have any? Don advised that the monies all are earmarked prior to award. The grant to the GTA is for a \$10,000,000 project to sewer the Village of Marion. None of the GWA monies is for PN fire hydrants, however the specific project we are not certain of. (Ted suggested that it may be for the upgrade to the water system north of Chambersburg where the fire hydrants have been out of service due to the minimal flow from the internal build-up of the lines). Mr. Ackerman asked whether street lights were an option. Don advised that we do have 4 neighborhoods that have street lights and they are totally funded by all of the properties on the streets where they are located through a street light fee on their taxes. Mr. Ackerman asked about road signs signifying Cascades Dr. off of Mont Alto Rd.(a state rd.) We shared the frustration of Penn Dot's continual push off of their responsibilities for their roads. Don advised that the township will address the signs in question. Mr. Ackerman had a few questions regarding some signage on Hotsprings Ct. Don advised that Hotsprings Ct. is currently not a township road. Any signage that he was recommending would be required to be paid for by the requestors and the township would be willing to install.

On a Bittinger/Ferguson motion carried unanimously the Supervisors approved Resolution #2024-02. The 2024 fee schedule has been updated as shown on the schedule distributed.

We received a list of non-emergency events for New Franklin Volunteer Fire Co.. The list of events was distributed to each Supervisor for review. On a Ferguson/Bittinger motion carried unanimously the Supervisors approved these events. The list of events is attached to the minutes.

Chairman Clapper discussed the Concession stand at Norlo Park's Softball Complex with the board.

Chairman Clapper advised the board that the bid packets for 2024 are being prepared. On a Bittinger/Ferguson motion carried unanimously, the Supervisors approved the advertisement of the bids to be on Feb  $5^{th}$  &  $9^{th}$  for opening on March  $7^{th}$ .

On a Ferguson/Clapper motion carried unanimously, the Supervisors approved the paying of the bills.

## Under Old Business -

Ted asked for an update on Archer Dr./Third St. Don updated that the asbuilt was complete and Endurance got approval by their lender so the dedication should be complete by the end of the month. We received an extension to the Third Street closure until April 30<sup>th</sup>.

## Under New Business -

 Don distributed the letter from Dewberry on what steps the township should take to respond to EPA. Don will be having a meeting with them next week and a meeting with Sam tomorrow.
