**Subdivision Review Fees:**

R and AR Zone                      \$50 for first lot \$20/lot thereafter  
C, I and CI Zone                    \$200 per lot

**Land Development -**

R, AR, C, I and CI Zone            \$200 first 1.00 acre or less  
    \$100 each acre (1.01 acre to 10 acres)  
    \$50 each acre (10.01 acres and over)

**Recreation-**

R & AR Zone                         \$1,000 per Dwelling Unit  
C, I & CI Zone                         \$10,000 x 10% of total Developed Area

**Demo Permit -**                      \$50

**Land Use Permit -**                    \$50 or \$2 per \$1,000 of the Construction Cost  
    Whichever is larger.  
Residential/Agricultural Cap- \$750  
Commercial/Industrial Cap-

**Septic Haulers Permit -**              \$35 (includes 1 truck) \$10 ea. additional truck

**Road Occupancy Permits -**          \$50 (\$250 Deposit)

**Junkyard Permits -**                    \$200 per year

**Trash Hauler's Permits -**            \$150 (includes 2 trucks) \$10 ea. additional truck

**Zoning Ordinance -**                    \$30 each (includes Zoning Map)


Community Center: \$150.00/ Day Monday- Thursday, \$275.00/ Day Friday- Sunday &

Holidays: plus a \$100 refundable deposit (if the facility is returned as good or better than it was received).


Softball Field: \$31/field/game or practice. \$88/field for tournament play
